SINGLE LOT: 67% (sixty-seven percent) ownership interest in the Corporation Marmo Quarries Canada Inc. (also referred to as "MQC") with registered office at 20, Queen Street West – SUITE 3300 Toronto ON M5H 3R3 Canada.

## **WHEREAS**

All the amounts expressed herein are in EUROS, official currency of the EU Member States; the previous company name of Fiber Srl was Fibra Srl (as results in the notarial deed dated as of August 8<sup>th</sup>, 2019 by Sara Rivieri Notary, Registration no. 3903);

## COMMUNICATE

- 1) Anyone interested in participating shall register on the website www.astemobili.it expressly accepting the general conditions, as well as the conditions and terms of this notice of sale;
- 2) When registering, each user is requested to choose a username and a password, as well as to provide a valid identity document. Username and password shall be used as credentials to access the website and participate in auctions;
- 3) In case the bidder is a legal entity, they shall register as such in the appropriate section providing the requested company information and the relevant required documents;
